#### **EXECUTIVE DIRECTOR'S REPORT:**

<u>Congregate Housing Rehab</u>: Mrs. Cook reported that the rehab is going very well. Gabe Dadio reported that the floors have all been removed, and the contractor is currently working on the management offices. Mrs. Cook shared pictures of the construction site with the Commissioners and all were very pleased with the project thus far.

<u>Affordable Housing Solar:</u> Gabe Dadio reported the solar panel install is complete and the system is up and running.

<u>Updating to Solar Energy for E/D Housing Units</u>: Mrs. Cook and Gabe Dadio reported that the solar systems are currently being designed for both Mt. Carmel and Hamden Villages. The roofs at Centerville will be inspected shortly in anticipation of the install at that Village. The project continues to move along nicely.

#### Miscellaneous Items:

<u>Annual Fair Housing Training & Commissioners Training</u>: Mrs. Cook reported that the staff recently participated in the Annual Fair Housing Training, which was done by Attorney Karen Kravetz in-house. Discussion took place regarding training for the newly appointed Commissioners Collins and Jefferson, and it will be scheduled in the near future.

**2023 Hamden Housing Authority Annual Report**: Mrs. Cook shared copies of the Annual Report with the Board members.

<u>Annual Summer Picnic</u>: Mrs. Cook reported that the residents Annual Summer Picnic is scheduled for June 12<sup>th</sup> at Congregate. The event will be held rain or shine, and there will be picnic fare as well as karaoke, raffle prizes, and the ice cream truck will arrive for dessert.
